If canceled in the month of the Wedding, Credit will be issued for Videography services in the amount of the 50%. No Videography will be fulfilled without your payment in full.

## MUTUAL COOPERATION...

The Clients and the Videographer consent to cheerful cooperation and communication with each other in order to achieve the best possible result within the understanding of this contract. We recommend that the Videographer will be provided with someone who knows most of the guests, who will point out key individuals to be included in the Visual Narratives.

The Videographer may also require assistance in organizing family groups. The Clients also agree to give the Videographer enough warning of key events to give the Videographer time to prepare e.g. cutting the cake, speeches etc.

The Clients will provide the Videographer and Assistant a meal to be eaten at the appropriate time as not to interfere with the Capturing of the Wedding Day Events.
